Jeff Trust Criteria

- (2) The Trustee shall be empowered to hold the net annual income already arisen from and yet to arise from the carrying on of the farming business together with all other assets which may now from time to time be held by the Trustee upon the Trusts herein declared to establish a fund, first priority being given to (a) and (b) and second priority being given to (c) to (i) such that, where reasonably practicable, available funds shall be utilised for the purposed set out at (a) and (b) and only where available funds cannot be reasonably utilised for those purposed then they may be utilised for the purposes set out at (c) to (i) and in all respects priority being given to underprivileged youths, as determined by the Trustee at its sole discretion:
 - (a) The assistance to young people for travel, accommodation and education in any aspects of farming including agriculture, horticulture, orcharding and animal husbandry, both general and specialised at what the Trustee in its discretion considers to be suitable places and educational institutes (including, but not in any way limiting the discretion of the Trustee, universities, polytechnics, farming training institutes and schools), priority being given in any one year to the classes in the order set out below as funds permit:
 - (i) Underprivileged youths who want to be trained in farming and would be likely to benefit from such training and have a need for assistance on account of the unsuitability of their existing environment or their state of health.
 - (ii) Youths who for other good reason would otherwise not readily have the opportunity to undertake such studies.
 - (iii) Other youths who, in the opinion of and at the unfettered discretion of the Trustee would find benefit from such assistance.
 - (b) Provide funds by way of grant to farm training institutions which are willing to take students who would fall within the criteria laid down in the objects above for the general or special purpose or purposes of such institutions as the Trustee in its discretion considers expedient;
 - (c) The therapy and training offered in The Salvation Army Bridge Programmes for Chemical Substance Abusers;
 - (d) The adventure-based training programme including but not being limited to the programme at The Salvation Army Outdoor Pursuits Centre in the Tongariro National Park;
 - (e) The Camping Programmes run by The Salvation Army in their youth camps;
 - (f) Selected training modules associated with the Employment Programmes run by the Trustee, particularly those specifically related to underprivileged young people where rural and outdoor related skills such as farming, horticulture and forestry are taught;
 - (g) For the creation of training and learning opportunities for under-privileged young people in the care of the Trustee in inner urban areas;
 - (h) The provision of supervision and ongoing support for young people referred to the Trustee through the courts and the diversion scheme;
 - (i) To establish and/or conduct and/or provide financial assistance to any person or organisation establish and/or conducting establishments whether permanent or temporary for the use of bible classes, youth groups, children's homes and other organised bodies belonging to any Christian denomination for holidays and/or retreats.
